I have been scrambling to get things in place for your conference. Some of you may have noticed on the website the change of venue for your conference. Unfortunately, Westwood High School became unviable. A big thank you goes to North Augusta and their advisers for their willingness to host the conference on such short notice. I apologize for the inconvenience this change may cause, and hope the change will not keep your chapter from attending the conference.

For the last several years District 2 has done online testing for objective tests in advance of the conference. This year all objective tests will be done the day of the conference.
